1. Introduction

The Department of Planning, Transport and Infrastructure (DPTI) owns, operates and maintains the Adelaide Metropolitan Passenger Rail Network (AMPRN) under the Rail Accreditation assigned to the Rail Commissioner. This Engineering Instruction is intended to ensure public transport safety and customer service levels are efficiently and effectively supported.

This instruction will focus on improving awareness of the public by providing adequate advisory warning on platform surfaces for "STAND BEHIND THE WHITE LINE".

2. Purpose

This instruction provides requirements for the advisory warning of "STAND BEHIND THE WHITE LINE".

3. Scope

This instruction is applicable to all station platforms on the Adelaide Metropolitan Passenger Rail Network (AMPRN).

A typical drawing for identifying the exact location for "STAND BEHIND THE WHITE LINE" on platforms is shown in Appendix 1.


The lettering shall be of 150 mm size font with Arial bold style. All letters shall be capitals.

The color of the paint shall be of N14 "White" in accordance with AS 2700 Colour Standards for General Purposes. The paint shall comply with the non-slip characteristics in accordance with AS 1428, AS 4586, AS 4663 and HB 197


